As on date, ESIC is catering to the needs of around 3.42 crore Insured Persons and 13.30 crore beneficiaries across 674 districts through its infrastructure comprising of 165 hospitals, 1590 dispensaries, 8 medical colleges, 65 Regional/Sub-Regional Offices, 610 Branch Offices and 105 Dispensary cum Branch Offices.




